* The first vehicle listed above should be the vehicle most frequently driven on campus.

Vehicles and Parking:

Vehicles on campus are subject to all the rules of the California Vehicle code, as well as good driving courtesy. Once arriving on campus, **students may not be in the parking lot or remain in their cars.**

- **Student parking is permitted only in designated areas in the main front parking lots.** This does NOT include spaces designated for VISITORS. ***If a student parks illegally the following disciplinary action may apply:***
 - **First time:** Warning/letter sent home
 - **Second time:** After school detention
 - **Third time:** Saturday School
 - **Fourth Time:** Loss of on-campus parking privilege
- **It is illegal to park in the red or yellow zones, areas with slanted lines or in reserved or visitor spaces.** The red zones are fire lanes and are under the jurisdiction of law enforcement. Rules governing the fire lanes are in effect 24 hours per day, 7 days per week. Fines are given at the option of law enforcement.
- **No student parking is allowed in the staff parking lots** located on the west side of campus, in the back of campus, the lot in front of the H-Wing, and the lot in front of the special education classrooms.
- **Vehicles may be towed** at the owner's expense if a parking lot violation occurs.
- **Vehicles parked on campus are subject to administrative search** if reasonable suspicion exists.
- **Vehicles parked off campus are not accessible during school hours.** Students may not be leave school grounds without permission during school hours.
- **A Parking Permit decal** must be displayed in each vehicle listed above in the **bottom left side of front windshield only**.
- **Only seniors who have paid for a designated senior parking spot may park in the senior parking lot.** All other student drivers must park in the overflow parking lot or on the streets in front of the school and in the nearby neighborhoods.
- **Any changes to the vehicle information** must be reported to the Administration Office. Please contact Teresa Mendoza via email at teresa.mendoza@sanjuan.edu with any questions.
