## School Description and Mission Statement (Most Recent Year)

### Mission Statement

Carriage Elementary, a visual and performing arts school, in partnership with families and community, will ensure all children build a strong academic foundation that empowers them to become responsible 21st century citizens through a balanced and engaging curriculum.

### School Profile

Carriage Elementary is one of 35 elementary schools in the San Juan Unified School District. Carriage Elementary is a kindergarten through 5th grade school located in Citrus Heights, California, serving approximately 625 students. We at Carriage believe in an environment that promotes academic success and positive self-esteem while valuing individual differences. Students are expected to be safe, be respectful, be responsible, and be good communicators with others. Through the use of positive reinforcement and consistent modeling, we are shaping our students into becoming model citizens.

We at Carriage believe that the administration, the teachers, our parents, and the community must work together in order to complete our mission of academic excellence and model citizenship for students. Teachers are professionals who strive to be cooperative, flexible, communicative, and supportive. Parents strive to create a supportive learning environment in the home. By working together with families and the community, we provide an atmosphere where students have an opportunity to develop to their fullest potential.

Our school programs are used to provide academic growth, enrichment opportunities, and extension activities for our students and for their families. Art, Music, and Physical Education are taught by specialists throughout the day. Each grade level organizes a musical production throughout the school year. This gives the students an opportunity to demonstrate their academic and content knowledge through alternate expressive means. Bridges after-school is a program which provides homework assistance, recreation, technology experience, and learning centers. Students who are designated as Gifted and Talented Education students (GATE) are given the benefit of an educational program designed to suit their capabilities and are encouraged to extend their learning beyond the grade level requirements. The district offers parenting courses to help parents learn skills that will assist them in refining their parenting skills. These courses are available on the district website.

Carriage also provides programs to meet the needs of learners who require individualized educational plans. We have two special education teachers with self-contained ASD classrooms, as well as two full time Resource teachers and two full time Resource Instructional Assistants. We have one Inclusion teacher who support students who are fully mainstreamed, with 1:2 Instructional Assistant support. The special education department supplements the regular education program and supports the district's mission by providing the best instruction and opportunities to improve academics and develop character for all students.

Carriage has a population of English Language Learners, speaking a variety of languages. Carriage has on staff a full time Language Specialist who works with our English learners in small groups according to skill level. We place our English learners in general education classrooms where the teachers deliver differentiated instruction on a daily basis.

Carriage Drive Elementary was named a California Distinguished School in 2010.

### Principal's Message

Carriage Elementary has a rich history of academic excellence, parent participation, and a visual and performing arts focus, all of which are characteristics of a dynamic and successful school. I am absolutely delighted to be leading a school team that is focused on teaching the whole child through a balanced and engaging curriculum, with an emphasis on student learning, collaboration, and commitment to high expectations for all students.

As principal, it is my intent to support the philosophy of Carriage School as outlined in the Strategic Plan. ### Quality, Currency, Availability of Textbooks and Instructional Materials (School Year 2015-16)

**Year and month in which data were collected:** September 22, 2015

San Juan Unified held a public hearing on September 22, 2015 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. The table displays information collected in September 2015 about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school. In July 2009, EC Section 60200.7, delayed all instructional materials adoptions and the development of curriculum frameworks and evaluation criteria until the 2015-16 school year. Since then specific legislation has authorized the State Board of Education to conduct adoptions in mathematics (Assembly Bill 1246) and English language arts/English language development (Senate Bill 201). #### School Facility Conditions and Planned Improvements (Most Recent Year)

Carriage Drive Elementary School opened in 1986 and is one of the newer schools in the district. The site is evaluated yearly on the condition of the roofs, heating and air-conditioning system, paint, electrical infrastructure, window system leakage, and handicapped accessibility. Currently there is sufficient space to house the student population. Site custodial staff clean the buildings, along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. Field repair and irrigation system retrofit continue to be a concern. In 2005, under the Measure J Bond, new gas service was installed to support future heating and air conditioning upgrades. Measure J replaced the roofing for the entire site in 2004.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in December 2015 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities.

Parents and community members have always been an integral part of the Carriage Program. ### School Safety Plan (Most Recent Year)

This school is linked directly to the San Juan Unified School District's Safe Schools Program. In partnership with the Sacramento County Sheriff's Department and the City of Citrus Heights Police Department (CHPD), each school becomes part of a safety zone that is patrolled daily by a sheriff's deputy or CHPD officer. The Deputy Sheriffs are assigned to a specific schools which are identified by geographic zones. The Deputy Sheriffs may move from one the geographic zone to another as safety needs dictate. The CHPD Police Officers work identified schools within the City of Citrus Heights and respond as safety needs dictate. In addition to daily support from a designated Sheriff's deputy or CHPD officer, this school is a part of the San Juan Unified School District's Safe Schools Task Force, which is comprised of safety teams from each of the school sites. Each school safety team meets regularly to discuss safety issues, update their site emergency plans, and to take steps to be proactive in preventing various types of school-related safety issues. Law enforcement provides speakers to address students, staff and community groups. Our safety team receives regular training through the Safe Schools Task Force. Each school site is responsible for updating their Comprehensive School Safety Plan by March 1st of every year. The plan must be approved by the School Site Council before being submitted to the district Safe Schools Manager. Every San Juan classroom has a standardized "Safety Folder" which serves as a guide for teachers, includes the site specific crisis response procedures and a district standardized emergency flip chart. In FY 2011-12, the district spent \$7,732,354 in restricted general fund for positions that would have usually been paid for by unrestricted dollars (SF-0) due to receiving American Recovery and Reinvestment Act (ARRA) Education Jobs Funds (EJF). The positions that were paid for included 21.0 FTE for Counselors, 24.0 FTE for Principals and 18.0 FTE for Vice Principals. Due to this change, many schools showed a decrease in unrestricted costs and an increase in restricted costs. In FY 2011-12, the district spent \$3,163,102 in restricted general fund from the Economic Impact Aid (EIA) grant. The expenses were coded with a central location (000) in 2011-12, when in the previous year the dollars were coded to site locations. The impact of this change will show a decrease in restricted expenses.

**Professional Development (Most Recent Three Years)**

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts and mathematics, and the ELA/ELD Framework. Specific professional development initiatives include: Critical Literacy, K-1 Reading, Making Meaning Through Close Reading and Writing, Engineering and Mathematics Inspiring Thinking Solutions (EMITS), Math to the Core, Expository Reading and Writing Course (ERWC), and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards (CCSS), teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
