School Description and Mission Statement (School Year 2019-20)

SCHOOL PROFILE

Arcade Fundamental Middle School is one of eight (8) middle schools in the San Juan Unified School District. Arcade is a fundamental school of choice. There are no attendance boundaries for Arcade. Parents choose to enroll their students at Arcade to provide them access to a strong academic foundation in a structured environment, with a family focus and a 21st century philosophy. The demographics of Arcade include, 9.93% are African American, 0.68% are American Indian or Alaska Native, 9.48% are Asian, 28.22% are Hispanic/Latino, 0.45% are Native Hawaiian or Pacific Islander, and 46.5% are White. 24.6% of Arcade's students are identified as English learners, with Spanish being the primary language spoken by our English learners. Additionally, 57.79% of our students are socioeconomically disadvantaged and 9.26% are receiving special education services.

Arcade's curriculum is aligned with California Content Standards and Common Core State Standards (CCSS). Effective written and oral communication has been a focus in all classrooms as a means to prepare all students for college, career, and citizenship. Arcade holds high expectations for their students and provides the support necessary for them to achieve academic success. There is a strong emphasis on writing across the curriculum and project based learning.

The following are integral components of Arcade:

- All students participate in the Homeroom class at the beginning of the school day. This class is designed to support student connection to school and academic success. Arcade uses Character Strong social-emotional curriculum in the Homeroom.
- Arcade's Parent Teacher Organization (PTO) is comprised of very active parents, who donate considerable time to support Arcade staff and students.
- Arcade provides STEAM education that includes robotics, programming, vocal and instrumental music, as well as visual arts.
- Field trips at each grade-level continue to be a priority at Arcade. Sixth grade students go to Mt. Hermon in the Santa Cruz Mountains, seventh grade students go to Wonder Valley in the Sierra Nevada Foothills near Sequoia National Park, and eighth grade students go to Yosemite National Park. These trips provide students with the unique opportunity to have hands-on educational experiences in an outdoor environment.

San Juan Unified held a public hearing on September 25, 2018 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements (Most Recent Year)

Modernization at Arcade Middle High School was completed in 2000. Major renovation of student restrooms was completed in 2010. The outside of campus and quad areas were significantly renovated in the summer of 2013. The scope included ADA (Americans with Disabilities Act), new ceramic wall tile, new epoxy floors, new toilet partitions and accessories, new plumbing fixtures, new paint, new glazing and other miscellaneous work. Currently, there are enough classrooms to house the student population. All classrooms have fire and intrusion monitoring and alarm systems, telephones and an internet connection. There is site custodial staff that clean the buildings. The district provides landscape maintenance and support to keep all the school systems functioning. The school is concerned about the condition of the play fields, the lack of space to increase program offerings, traffic congestion during student drop-off and pick-up, and the adequacy of storage space for equipment and supplies. A site-wide landscape and irrigation project was completed winter 2013 using Measure J funds.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in October 2019 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities.

School Safety Plan (School Year 2019-20)

This school is linked directly to the San Juan Unified School District's Safe Schools Program. The Safe Schools Program has a Community Safety Specialist assigned to this school within a geographic zone that includes nearby schools. In addition, via a partnership with the Sacramento Sheriff's Department (SSD) and the Citrus Heights Police Department (CHPD), there are two uniformed deputy sheriff's and two uniformed CHPD officers assigned to patrol the school district including this school. The Deputy Sheriffs are assigned to patrol a geographic zone either on the east side of the district or the west side of the district. They are assigned specific schools within their assigned zone and respond to this school, or others, as safety needs dictate. The two CHPD Police Officers are School Resource Officers (SRO) who work identified schools within the City of Citrus Heights and respond as safety needs dictate. The two law enforcement agencies will overlap response when necessary. The Deputy Sheriff's and/or CHPD Officers are dispatched to critical incidents via the Safe Schools Dispatcher, a law enforcement dispatcher or via a direct report from a school staff member, school visitor or other person. This school has a school safety team which reviews safety matters that may affect the campus. Our school safety team meets regularly to discuss safety issues, update our site emergency plan, and to take steps to be proactive in preventing various types of school-related safety issues. Community Safety Specialists and law enforcement provides speakers to address students, staff and community groups on matters of school safety. Our safety team receives training, when requested, from Safe Schools or law enforcement. This school is responsible for updating our Comprehensive School Safety Plan (CSSP) by March 1st of every year per the Education Code. As part of the update, this school meets at least once per year with a law enforcement officer to review the CSSP, has the local fire department review the CSSP and we hold a community meeting to review the CSSP. The CSSP must be approved by the School Site Council before being submitted to the district safe schools manager. Every classroom has a standardized "Safety Folder" which serves as a guide for teachers, includes the site specific crisis response procedures and a district standardized emergency flip chart. This school conducts and keeps a record of all fire drills, lockdown drills, shelter in place drills and/or earthquake drills up to or in excess of what is required by the Education Code.

Supplemental/Restricted expenditures come from money whose use is controlled by law or donor. Money designated for specific purposes by the district or governing board is not considered restricted. Basic/unrestricted expenditures, except for general guidelines, is not controlled by law or donor.

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
