### School Description and Mission Statement (School Year 2020-2021)

#### MISSION STATEMENT

Albert Schweitzer Elementary, an exemplary model of sophisticated student expression, empowers each child to collaborate and problem solve as a compassionate and highly literate twenty-first century citizen through innovative, research-based, instructional strategies that incorporate strong character values in partnership with families in a nurturing environment.

#### SCHOOL PROFILE

Albert Schweitzer Elementary is one of 41 elementary/K-8 schools in the San Juan Unified School District. Our school provides a comprehensive academic program based on the Common Core State Standards. Schweitzer has two Special Education SDC LH, K-2nd grades and 3rd-5th grades. We also have an Early Childhood Education preschool on our campus serving pre-K students with language/speech needs. Our school has a comprehensive balanced literacy program based on the district-adopted English Language Arts curriculum from Benchmark Publishers for all grade levels with a supportive piece from the reading and writer's workshop. Our math program uses components of critical math integrated into the district's adopted math curriculum, enVision, for all grade levels. As a team of committed educators, we strive for research-based professional development to enrich our instruction such as Project GLAD (Guided Language Acquisition Design) that provides learning strategies based on student collaboration that supports both English learners and English only students by accessing and mastering academic content standards. All grade levels have received responsive reading instruction with K-2nd grades completing their fourth year, working on the personalization and differentiation of reading instruction through the use of formative assessment tools, shared, and guided reading. We believe students can achieve at high levels, and we tailor our instructional practices to challenge and support all students.

An important component for our students to learn is to create a safe and risk-free environment where every child feels valued and successful in school academically, socially, and emotionally. A cohort of our teachers will begin this work with implementing PBIS, Positive Behavioral Intervention and Supports, along with bringing Mindfulness activities into the classroom with school-wide professional development to deepen our learning on the multiple students' behaviors that can affect their learning.

The goal of Schweitzer School is to provide each student with a challenging and rigorous curriculum appropriate to his/her academic level. We believe every child can achieve academic success. To this end, every child is provided with quality instructional experiences which recognize, support and maintain high expectations for all students. With parents and teachers working together as a team towards the same goal, every child will succeed. In order to give each child the best opportunity for success, we keep children first in all that we do. This is our core value and common cause.

We also believe that children need exposure to instruction via the arts. We hold a bi-weekly whole school “sing” where we sing traditional and new songs. This has been in place for many years and is a well-loved tradition of our school. PTA directs a school play every year that includes all students interested in participating. In spring, a production by Starstruck, a dance program wherein each classroom has an individual dance routine, is performed at two night shows. Students in grade 1 through 5 have one art class and two to three PE classes per week. There is both band and choir as after-school programs. K-Kids, an elementary student leadership organization that falls under Kiwanis, involves students leading projects/activities/events on campus and in the community. At Schweitzer School, we take the business of loving and teaching children seriously. Each person at our school approaches his/her task with a keen understanding of the honor that it is to be able to touch the future through our children.

San Juan Unified held a public hearing on September 22, 2020 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. ## School Facility Conditions and Planned Improvements

Albert Schweitzer Elementary School, constructed in 1961, was modernized during the 2000-2001 school year. The scope included: roof replacement, interior, and exterior painting, window system repair, energy-efficient heating and cooling system upgrade, new doors with handicapped accessible hardware, restroom restoration, electrical infrastructure upgrade to provide for internet, cable, telephone, new fire, intrusion, and intercom system, throughout the school. New carpet and tile was installed in most classrooms. Currently, there is sufficient space to house the student population. There are two Discovery Clubs on site. Site custodial staff clean the buildings, along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. Field repair, driveway resurfacing, and irrigation system retrofit continue to be a concern. During the summer of 2008 a new portable 5-classroom wing with Boys, Girls and Staff Restrooms was constructed along with a major landscape and paving project through the Measure J Bond. During the summer of 2014, the restrooms in our main quad were updated with new concrete poured in the main hallways.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in October 2019 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities.

### School Safety Plan (School Year 2020-2021)

San Juan Unified School District makes safety a top priority. In accordance with the California Education Code, each school site's comprehensive school safety plan is reviewed, edited as needed and approved by the school site safety team by March 1 of each year. The plan includes a review of safety data for the campus, incident response information in case of fire, earthquakes and other dangers, and details on safety policies. A copy of the plan is available for review in the school office.

Drills are held on a regular basis to include fire drills, earthquake drills and intruder drills.

Safety is a shared responsibility, and our school is supported by the district's Safe Schools program in coordination with the Sacramento Sheriff's Department and Citrus Heights Police Department. The Safe Schools program provides district employed safety specialists who provide safety advice, training and respond to critical incidents. Sworn law enforcement is called, when needed, to assist the safety specialists. In addition, San Juan Unified has the option of employing uniformed law enforcement officers when needed.

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
