### Principal's Message

It is my distinct pleasure to be the Instructional Leader at Ralph Richardson Center. In alignment with the San Juan Unified Strategic Plan, and with thoughtful shared input and deliberate collaboration, staff and families work together to provide optimum educational opportunities for our unique learners. I invite you to come for a visit, I predict you will be forever changed.

### Mission Statement

Ralph Richardson Center is a place where, with respect to individual needs and learning styles, and in a collaborative manner, staff challenge and support students to achieve their optimal potential and independence by providing effective instruction and related support services in a nurturing environment.

### School Profile

Ralph Richardson is one of three special education schools in San Juan Unified School District. Our site boasts programs serving students with varying needs. Currently, we provide specialized instruction for pre-schoolers who present with special needs, as well as typically developing youngsters in Early Childhood Education. Additionally, we have five special day classes for students with profound cognitive, physical and/or health needs, and three middle/high/transition school programs serving students impacted by autism to the most severe degree.

Given our recent performance data, we have concluded our diploma and non-diploma bound students need continued support to perform at higher levels of achievement. In order to address student needs, we have selected four goal areas that we have agreed would make a significant positive impact for student growth and achievement. Additionally, we reviewed the San Juan Unified School District Strategic Plan to ensure our goals are in alignment.

1) Richardson staff will increase their effectiveness and comfort level for utilizing technology and specific teaching methods, strategies and/or programs (for example; skills of daily living, communication programs, mobility programs; MOVE (Mobility Opportunities Via Education/Experience), pre-vocational/vocational, academics and others) to support students with moderate/severe disabilities and orthopedic impairments.

2) Richardson staff will learn and implement ways to communicate and collaborate with all stakeholders in a more meaningful, timely, and effective manner and increase knowledge and interactions that are effective in attending to cultural responsiveness.

3) Richardson staff will learn and implement transition plans to assist students move to less restrictive environments, move from grade to grade and transition more successfully into adult programs.

The Principal and leadership team did the initial analysis of data and reported to the stakeholders. Site goals were drafted collaboratively by the Principal, leadership team and school staff based on input from parents and all teaching and support staff. Responsibility will be shared with all stakeholders and progress reported using a transparent communication format.

Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. ## School Facility Conditions and Planned Improvements

Ralph Richardson Center has been modernized, using Measures S and J funding, over the last five years. The parking area was repaved during the summer of 2005. All rooms used by students are cleaned daily, with special attention to areas housing medically fragile students. All classrooms are currently being used for instruction or instructional support. In 2009, major ADA and Safe Routes improvements were made including landscape, irrigation, parking lots, and sidewalks using Measure J funds.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The most recent modifications to the Richardson campus was the installation of security fences around the perimeter of the school which was completed in September of 2016. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in October 2020 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually, the district budgets for deferred maintenance activities.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

### School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

## Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
