Even though you have not yet entered into subcontracts, you must submit a DAS 140 for all crafts that will be employed on this Project. The District understands that you may have to estimate certain information on those forms at this time, and anticipates that you will submit updated forms, if necessary, prior to commencement of construction. When you have entered into subcontracts, each subcontractor must submit new DAS 140s within 10 days of contract date, and before any work on that craft starts on the Project.
